### Kim Aarenstrup

Kim heads the Danish National Cyber Crime Centre. He is inter alia the former Chief Information Security Officer at the A.P. Moller - Maersk Group. For more than 13 years, he led the information security activities across a number of areas and business units, in order to raise the bar for the business protection and information security in a very large and complex enterprise, with numerous office locations, ships, rigs and a large multicultural population of employees.

### John Bowman

John is a Senior Principal at the London office of Promontory Financial Group. His role is to advise clients on all aspects of compliance with data protection laws and regulations with a particular focus on the forthcoming EU General Data Protection Regulation. Prior to joining Promontory, John worked at the UK Ministry of Justice where he was the lead negotiator on the GDPR for the UK at the DAPIX working group in Brussels. John also represented the UK on the European Commission's Article 31 Committee which considered third country data protection adequacy decisions, including the EU-US Safe Harbour framework. John's other international work included representing the UK at the Special Commission on the practical application of the Hague Conventions on international child abduction.

FBI Supervisory Special Agent Chuck Esposito is an Assistant Legal Attaché assigned to the U.S. Embassy in Copenhagen. Prior to arriving in Copenhagen in August 2013, he was a Unit Chief in the FBI's Cyber Division and prior to that he led a cyber squad in the FBI's San Francisco Field Office. Chuck has a Bachelor's Degree in Computer Science and over 30 years of law enforcement experience.

### Michael Hopp

Attorney-at-Law Michael Hopp has been employed with Plesner Law Firm since 2000 and is a Partner in the TMT team in Plesner's IP-law department, where he is responsible for Plesner's legal advice on data protection, marketing law and consumer law. Prior to this he worked at the Networks and Communications Laboratory of Hewlett-Packard Laboratories in Bristol, and Racal-Comsec Ltd (Salisbury, UK), latterly as Chief Mathematician. His research interests mainly relate to information security and applications of cryptography. He has edited over twenty international security standards and in recognition of his contributions to international standards in 2011 he received the prestigious IEC 1906 award. He has published well over 200 research papers and acts as a consultant on a variety of topics in information security.

### Henning Mortensen

Henning Mortensen is a Senior Adviser at the Confederation of Danish Industries. He is the secretary of the Information Security Committee, giving advice on security challenges and influencing political decision making in this area. He has authored and co-authored a plethora of security books, booklets and guidelines for Danish Companies, including topics like ISO27000, security management, security policies, spam, spyware, BOTs, phishing, physical security, etc.
